2. This is to inform you that the Ministry of Education, Tertiary Education, Science and Technology is awarding your company the contract for the above-mentioned project for the total amount of **Rupees Five million, Four hundred and Eighty-Four thousand, One hundred and Thirty-Six only (Rs. 5,484,136.00)**, inclusive of a contingency sum of **Rupees Three hundred thousand only (Rs 300,000.00)** and exclusive of VAT.

3. In accordance with GCC 13.1 of the bidding document, except for the cover mentioned in (d)(i) hereunder, the other insurance covers shall be in the joint names of the Contractor and the Employer and the minimum insurance amounts shall be:

It will extend to the property of the Procuring Entity as well.

5. The start date of the works shall be within **14 days** as from the handing over of the site. The completion shall be within a period of **135 days** as from the start date of works.
6. Also note that you will have to sign a contract with the Ministry in due course.
7. This award of contract is also subject to submission of the relevant documents within the specified deadline.
8. This letter of Acceptance together with the Ministry's Invitation to Bid, Procurement ref No: MOETEST/Works/ONB 016/2021-2022 (IFB/349) and your offer dated 04 April 2022, shall constitute a binding agreement between Krish Garuda Enterprise Ltd and the Ministry of Education, Tertiary Education, Science and Technology, until a formal contract agreement is signed.

Contract Agreement

THIS AGREEMENT made on the ^{28th} day of September, 2022, between **Ministry of Education, Tertiary Education, Science and Technology** (hereinafter "the Employer"), of the one part, and **Krish Garuda Enterprise Ltd, Lot 4, Rue Barry, Curepipe** (hereinafter "the Contractor"), of the other part:

WHEREAS the Employer desires that the Works known as **Upgrading of Home Economics Room at Gaetan Raynal State College, Belle Rose** for the total amount of **Rs 5,484,136.00 (Rupees Five million, Four hundred and Eighty Four thousand, One hundred and Thirty Six only), inclusive of a contingency sum of Rs 300,000.00 (Three hundred thousand only) and excluding VAT**, should be executed by the Contractor, and has accepted a Bid by the Contractor for the execution and completion of these Works and the remedying of any defects therein,

The Employer and the Contractor agree as follows:

1. In this Agreement words and expressions shall have the same meaning as are respectively assigned to them in the Contract documents referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement. This Agreement shall prevail over all other Contract documents.
 - (a) the Letter of Acceptance
 - (b) the Bid
 - (c) the Addenda No 1
 - (d) the Appendix to the General Conditions of Contract
 - (e) the General Conditions of Contract;
 - (f) the Specifications
 - (g) the Drawings; and
 - (h) the completed Schedules.

In consideration of the payments to be made by the Employer to the Contractor as indicated in this Agreement, the Contractor hereby covenants with the Employer to execute the Works within a period of 135 days as from the start date of works and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.



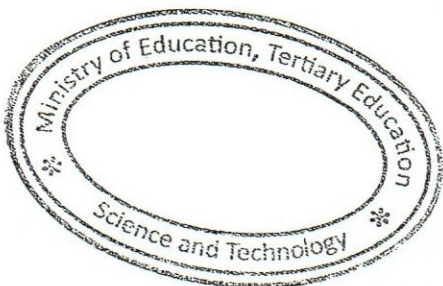
