Contract Agreement

This CONTRACT (hereinafter called the "Contract") is made the ^{26th} day of the month of ~~February~~ 2024, between, on one hand, the **Ministry of Education, Tertiary Education, Science & Technology** (hereinafter called the "Employer") and, on the other hand, **RSL Security Services Ltd** (hereinafter called the "Service Provider").

WHEREAS

- (a) the Employer has requested the Service Provider to make provision for **Watch and Security Services in Schools/ Institutions- 3 Years** as defined in the General Conditions of Contract attached to this Contract (hereinafter called the "Services");
- (b) the Service Provider, having represented to the Employer that they have the required professional skills, and personnel and technical resources, have agreed to provide the Services on the terms and conditions set forth in this Contract at a contract price of equivalent of: **(i) Zone 3-Rs133,580,137.68** (Rupees One Hundred and Thirty-Three Million, Five Hundred and Eighty Thousand, One Hundred and Thirty-Seven and cents Sixty-Eight only) excluding VAT and **(ii) Zone 4- Rs 105,951,744.24** (Rupees One Hundred and Five Million, Nine Hundred and Fifty-One Thousand Seven Hundred and Forty-Four and cents Twenty-Four only) excluding VAT. The contract shall be for an initial period of 12 months effective as from date of signature of contract.

NOW THEREFORE the parties hereto hereby agree as follows:

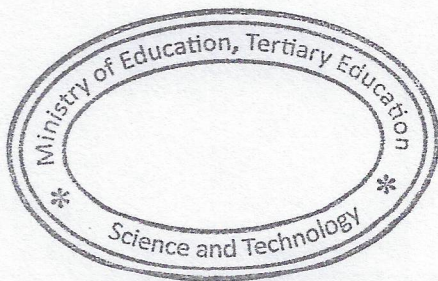


