### Contract Agreement

This CONTRACT (hereinafter called the "Contract") is made the 26<sup>th</sup> day of the month of February 2024, between, on one hand, the **Ministry of Education, Tertiary Education, Science & Technology** (hereinafter called the "Employer") and, on the other hand, **Rapid Security Services Ltd** (hereinafter called the "Service Provider").

WHEREAS

- (a) the Employer has requested the Service Provider to make provision for **Watch and Security Services in Schools/ Institutions- 3 Years** as defined in the General Conditions of Contract attached to this Contract (hereinafter called the "Services");
- (b) the Service Provider, having represented to the Employer that they have the required professional skills, and personnel and technical resources, have agreed to provide the Services on the terms and conditions set forth in this Contract at a contract price equivalent of: **(i) Zone 1- Rs194,244,480.00** (Rupees One Hundred and Ninety-Four Million, Two Hundred and Forty-Four Thousand, Four Hundred and Eighty only) excluding VAT and **(ii) Zone 2- Rs 163,668,960.00** (Rupees One Hundred and Sixty-Three Million, Six Hundred and Sixty-Eight Thousand, Nine Hundred and Sixty only) excluding VAT. The contract shall be for an initial period of 12 months effective as from date of signature of contract.

NOW THEREFORE the parties hereto hereby agree as follows:

1. The following documents shall be deemed to form and be read and construed as part of this Agreement, and the priority of the documents shall be as follows:

- (d) the Scope of Service and Performance Specifications;

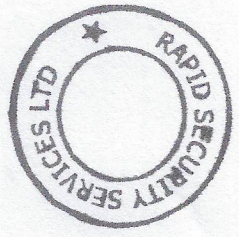
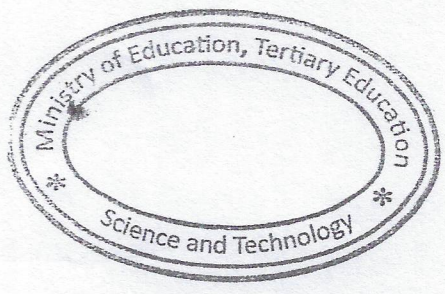
