You are hereby requested to:

- (i) forward the insurance cover within **21 days** pursuant to GCC Clause 2.6 and Section I, Sub Clause 13.1 (e), paragraph 2,3 & 4 of the Bidding document pertaining to insurance covers. The amount for Professional Indemnity Insurance Cover should be 0.5 times of the contract price and the Third Party Liability Insurance Cover should be 0.1 times of the contract price;
- (ii) submit a Performance Security, for an amount of 10 % of the annual contract value within 21 days as from the date of the Letter of Acceptance in the form of a Bank/ Insurance Guarantee. The Performance Security shall be valid until a date 28 days after the Completion Date of the contract pursuant to ITB 34.1 and GCC 2.10 of the Bidding document;
- (iii) sign a Contract Agreement, after successful vetting of the Insurance Cover and Performance Security. You will have to arrange to be accompanied by a witness and bring along your company seal for signature of Contract Agreement (National Identity Card should be produced).

You are hereby instructed to proceed with the execution of the contract in accordance with the terms and conditions of the Bidding Documents, subject to submission of the documents as per (i) and (ii) above and signature of contract.

 - (a) the Service Provider shall carry out the Services in accordance with the provisions of the Contract; and

(b) the Employer shall make payments to the Service Provider in accordance with the provisions of the Contract.



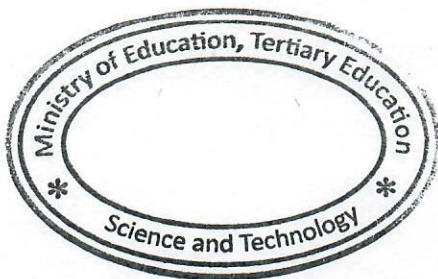
