ENLISTMENT OF SUPPLY TEACHER FOR THE TEACHING OF ORIENTAL LANGUAGES IN PRIMARY SCHOOLS

Applications are invited from:

- (a) retired public officers, who previously held one of the posts mentioned below:
 - (i) Deputy Head Teacher (Oriental Languages)
 - (ii) Primary School Educator (Oriental Languages)
 - (iii) Primary School Educator for the teaching of Oriental Languages and
- (b) suitably qualified candidates <u>outside the service</u>

who wish to be considered for enlistment as Supply Teacher for the teaching of the subjects listed below in Primary Schools during the Academic Year 2026:

- 1. Hindi
- 2. Urdu
- 3. Tamil
- 4. Telugu
- 5. Marathi
- 6. Arabic
- 7. Modern Chinese

2. AGE LIMIT

Candidates should not have reached their <u>70th birthday</u> by the closing date for the submission of applications.

Note:

Officers who have retired in the interest of the Public Service or on medical grounds will not be considered.

3. QUALIFICATIONS

Candidates should possess:-

A. (a) Cambridge School Certificate with credit in at least five subjects including English Language, the appropriate Oriental Language, Mathematics and French obtained at not more than two sittings <u>or</u>

(b) Passes not below Grade C in at least five subjects including English Language, the appropriate Oriental Language, Mathematics and French obtained at not more than two sittings at the General Certificate of Education "Ordinary Level" provided that at one of the sittings, passes have been obtained either (i) in five subjects including English Language with at least Grade C in any two subjects or (ii) in six subjects including English Language with at least Grade C in any one subject.

Note

Candidates not possessing a credit in English Language at the Cambridge School Certificate will also be considered provided they possess passes in at least two subjects at "Principal Level" and one subject at "Subsidiary Level" as well as the General Paper obtained on one certificate at the Cambridge Higher School Certificate Examinations.

B. A Cambridge Higher School Certificate or Passes in at least two subjects obtained on one certificate at the General Certificate of Education "Advanced Level".

<u>OR</u>

Equivalent qualifications to **A** and **B** above acceptable to the Ministry.

C. Candidates should be computer literate.

Qualification at **A** above should have been obtained prior to qualification at **B** above.

NOTE

- 1. For the teaching of Tamil, Telugu and Marathi
 - (i) Consideration may also be given to candidates possessing the School Certificate with credit in five subjects including English Language, the appropriate Oriental Language, Mathematics and French.
 - (ii) In the absence of sufficient qualified candidates, consideration may also be given to candidates who have
 - (a) passed the Cambridge School Certificate and have obtained a credit in the relevant Oriental Language; or

- (b) passes in <u>five</u> subjects at the General Certificate of Education "Ordinary Level" including English Language with at least Grade C in two subjects including the appropriate Oriental Language on <u>one</u> certificate.
- 2. For the teaching of Modern Chinese, consideration may also be given to candidates who have sat for Cambridge School Certificate and have obtained a credit in <u>either Mandarin or Modern Chinese</u>.
- 3. Candidates should provide written evidence of experience/knowledge claimed.
- 4. The onus for the submission of written evidence of experience/ knowledge claimed and equivalence of qualification (if applicable) from the relevant authorities (Higher Education Commission or Mauritius Qualifications Authority or National Equivalence Committee) rests with the candidates. Applications will not be considered in case of non-submission of written evidence of experience/ knowledge claimed and Equivalence Certificate, as appropriate, by the closing date.
- 5. The Ministry reserves the right to convene <u>only</u> the best qualified candidates for interview.

4. CONDITIONS OF EMPLOYMENT AND REMUNERATION

- 4.1 The enlistment will be purely on a temporary basis, as and when required, and may be terminated at any time. Selected candidates will not have any claim for permanent appointment.
- 4.2 Candidates will be paid allowance at the rate of **Rs 18650** monthly on a pro-rata basis, on days on which they actually work.
- 4.3 Bus fares will be refunded on the basis of the number of days of attendance at the approved rates.

5. TRAINING:

Selected candidates from outside the service will be required to follow a two weeks' crash training course, at the Mauritius Institute of Education, prior to being posted to Government Primary Schools.

6.3 Qualified candidates should submit their application form together with copies of Birth Certificate, Marriage Certificate (where applicable), National Identity Card, academic qualifications and evidence of teaching experience, if any, as well as documentary evidence regarding computer literacy.

7. <u>IMPORTANT</u>

- (i) Candidates should <u>clearly</u> indicate on their Application Forms the subject for which they are applying. <u>Failure to do so may entail their elimination from the competition.</u>
- (ii) Candidates willing to be considered for more than one subject should fill in separate Application Forms.

- (iv) Incomplete, inadequate or inaccurate filling of the Application Form may entail elimination of the applicant. Only the prescribed Application Form should be used.
