### Press Release

1. The Ministry of Education and Human Resources is in the process of developing a strategic plan for the transformation of the Mauritian education sector.
2. One of the key and persistent challenges concerns the mode of admission of students in secondary schools. A new approach to this issue is necessary to mitigate the ongoing intense competition while ensuring the wellbeing of our learners.
3. Following the *Assises de l'Éducation* held in 2025, two main proposals regarding access to secondary education emerged:

About <b>2400</b> of learners, depending on relative performance and parental choice, may seek admission in <b>Grade 7</b> in 21 National Secondary Schools, consisting of 12 former Academies, 5 upgraded Regional Schools and 4 Service Diocésain D'Éducation Catholique (SeDEC) schools.  The National Certificate of Education at Grade 9 is abolished.	About <b>2400</b> students may seek admission to a school in <b>Grade 10</b> in <b>21</b> National Secondary Schools based on the results of the NCE and according to a revised modality.

Under each proposal, there is the option for the National Schools to operate on a single-gender (except for the Mahatma Gandhi Institute) or a co-education model.																																										

4. To finalise the strategic education plan, the Council of Ministers has approved the organisation of public consultations on these two proposals and the various modalities associated with them, so that one of these proposals can be incorporated into the strategic plan.

5. As part of these consultations, the Ministry will meet with its key partners to discuss these two proposals from 8 December 2025 to 20 January 2026.

6. An online questionnaire to gauge public opinion will be active from Friday 16 January 2026, 12h00 to Monday 19 January 2026, 12h00.
