- QUESTION OF: PROMOTING EFFICIENT UNITED NATIONS MECHANISMS TO CHANNEL AND MONITOR AID FOR HUMANITARIAN PURPOSES, THROUGH WHICH RIGHTS AND FREEDOMS SET FORTH IN THE 'UNIVERSAL DECLARATION OF HUMAN RIGHTS' CAN BE REALISED

The General Assembly,

<u>Bearing in mind</u> that education remains an inaccessible right to 72 million of children around the world and that 759 million of adults are illiterate,

<u>Noting with regret</u> that one in five women have experienced discrimination in humanitarian crisis in the form of economic inequality, politics, domestic abuse and sexual harassment by activists and other stakeholders,

<u>Conscious</u> that the advent of human rights, mistreatment of asylum seekers is on the rise, though it has been stated that everyone has the right to seek and enjoy other countries' asylum from persecution,

<u>Deeply concerned</u> by the worldwide rise in the drastic effects related to climate change, leading to severe health risks and many more because of a lack of assistance,

<u>Emphasizing</u> that Yury Fedotov, Executive Director of the UNODC, confirmed that human trafficking especially child soldiers and forced labour has reached horrific dimensions because of armed conflicts and poverty,

1. <u>Requests</u> the UN to set up an early warning system for better classification of humanitarian crisis through green, yellow and red lights, where green is the lowest and red is the highest degree of emergency;

2. <u>Invites</u> the International Police Organisation (Interpol) to approve a scheme of surprise checks within areas prone to child labour, that is assigned to be conducted by all Member States;

3. <u>Urges</u> the UN to influence host countries of refugees to provide undocumented asylum seekers with birth certification or other special identification documents that will enable their recognition legally;

4. <u>Demands</u> all member states to strengthen legislations and develop national organisations in order to provide adequate healthcare and overall support to victims of domestic abuse and sexual harassment;

5. <u>Appeals</u> to the UNHCR to help member states clearly define the priority of the allowance of food and primary and emergency health services package, irrespective of being a citizen or a refugee, thus protecting them from famine and illnesses;

6. <u>Endorses</u> the implemention of measures by leaders and partners through country policies and action plans by shifting the world towards a climate change resilient economy;

7. <u>Calls upon</u> all victims of income inequality to report their cases to the International Development Law Organisation (IDLO) so that the concept of equal pay for equal work is attained by the standardisation of salaries of both genders;

8. <u>Instructs</u> the International Criminal Court (ICC) to review all trials suspected as discriminatory and take the necessary actions, thus alleviating the rampant corruption and conflict;

10. <u>Congratulates</u> the World Food Programme (WFP) for donating food assistance in countries in emergency and working with communities to improve and build resilience for the malnourished;

11. <u>Approves</u> the reconsideration of the economy of countries that can lead to fewer conflicts so that the needs of the population and the member states are in mutual agreement.
