QUESTION OF: ENCOURAGING INTERNATIONAL RESPONSE TO ADDRESS LARGE MOVEMENTS OF REFUGEES AND MIGRANTS

The General Assembly,

<u>Deploring</u> the fact that refugees are now facing complex hurdles in the host countries such as limited access to potable water, living space, hygiene as well as employment in the long run,

<u>Emphasizing</u> the inequitable access of refugees and migrants to health promotion and disease prevention with discrimination based on gender, age, religion, nationality or race,

<u>Expressing deep concern</u> for the 40 million people who were internally displaced due to armed conflicts, inhumane violence and human rights violation,

<u>Noting with regret</u> that many refugees have experienced a wide range of abuses on the way, including sexual and gender based violence,

1. <u>Invites</u> the international community and humanitarian supports such as NGOs and the UNHCR to aid host member states with adequate resources to help satisfy the basic needs of the refugees in their country;

2. <u>Requests</u> help from NGOs to provide financial support and to help relocate the refugees in refugee camps and provide funding for the construction of sustainable refugee settlement;

3. <u>Recommends</u> that campaigns be set out to the country hosting the refugee to raise the feeling of commiseration for the purpose of preventing acts of violence against refugees in school and prevent discrimination in order to allow easy integration of the refugees in the society;

4. <u>Further recommends</u> that governments in collaboration with NGOs provide free medical assistance to refugees and migrants, through an increase in the number of doctors and social workers in the refugee camps, as well as better access to medicine;

5. <u>Suggests</u> the United Nations to have a better timing of transportation in terms of air transport in safer areas for accommodation by engaging its best special officers to distinguish terrorists among refugees, thus, minimizing the problem of xenophobia;

6. <u>Demands</u> a boost in relevant education, creation of jobs and income generation schemes for refugees and migrants, further expanding opportunities for resettlement or other forms of admission to other countries;

7. <u>Further requests</u> the assistance of humanitarian supports such as the UN affiliated-organisations like World Food Programme (WFP), and the Office for the Coordination of Humanitarian Affairs (OCHA) to help in resolving refugee crisis;

8. <u>Recommends</u> military escorts in safer areas when displacing refugees to promote better coordination among forces and enhancing mechanisms to identify vulnerabilities to further protect refugees and migrants;

9. <u>Strongly condemns</u> violation of human rights for refugees, and the need to ensure the monitoring of refugees so that no human rights are violated;

10. <u>Invites</u> the implementation of social intervention strategies to fight against sexual exploitation of adolescents and children;

11. <u>Urges</u> the host countries to stop marginalising migrants at workplace and provide them with access to basic needs and services.
