

**Contract Agreement**

THIS AGREEMENT made on the <sup>15<sup>th</sup></sup> day of <sup>February</sup> . . . . ., <sup>2022</sup>, between **Ministry of Education, Tertiary Education, Science and Technology** (hereinafter "the Employer"), of the one part, and **AWL Trading & Contracting Ltd, 32-34, Reserve Street, Cassis, Port Louis** (hereinafter "the Contractor"), of the other part:

WHEREAS the Employer desires that the Works known as **Completion of Outstanding Works for the Construction of Shelter at Cascavelle Government School** for the total amount of **Rs 8,872,500.00 (Rupees Eight million, Eight hundred and Seventy Two thousand and Five hundred only)**, inclusive of a contingency sum of **Rs 375,000.00 (Rupees Three hundred and seventy five thousand only)** and excluding VAT, should be executed by the Contractor, and has accepted a Bid by the Contractor for the execution and completion of these Works and the remedying of any defects therein,

**DO/MN/15/2022-2023 – MOETEST/Works/ONB 076/2021-2022 [IFB/2022/601]**

The Employer and the Contractor agree as follows:

1. In this Agreement words and expressions shall have the same meaning as are respectively assigned to them in the Contract documents referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement. This Agreement shall prevail over all other Contract documents.
  - (a) the Letter of Acceptance
  - (b) the Bid
  - (c) the Appendix to the General Conditions of Contract
  - (d) the General Conditions of Contract;
  - (e) the Specifications
  - (f) the Drawings; and
  - (g) the completed Schedules.
3. In consideration of the payments to be made by the Employer to the Contractor as indicated in this Agreement, the Contractor hereby covenants with the Employer to execute the Works within a period of 180 days as from the start date of works and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.

Notwithstanding anything to the contrary in this agreement, AWL Trading & Contracting Ltd agrees to indemnify and hold harmless the Ministry of Education, Tertiary Education, Science and Technology from any claim brought by or on behalf of third parties against it, its préposés and/or agents, for any loss or damage caused to third parties or on their behalf by the acts and omission of AWL Trading & Contracting Ltd or its employees, préposés and/or agents during the execution of the works pursuant to the agreement.

6. Notwithstanding anything to the contrary in this agreement, the Ministry of Education, Tertiary Education, Science and Technology shall be entitled to claim from AWL Trading & Contracting Ltd such loss and damages caused to it by the acts or omissions of AWL Trading & Contracting Ltd, its employees, préposés and/or agents.

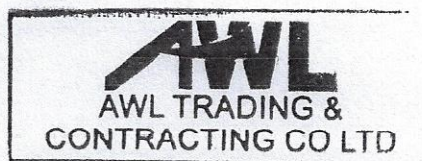
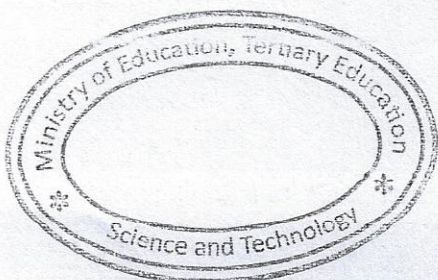

<b>GCC 37.1</b>	Delete “, and, in the case of lump sum contract, also in the activity schedule, ”in line 1 of sub clause 37.1
<b>GCC 37.2</b>	Add “Omissions and additions shall be measured and valued at fair rates and prices, having regards to current market prices. The contractor shall supply all information required by the Project Manager to enable him to value a variation” after line 6 of clause 37.2
<b>GCC 38.1</b>	Delete the words “, or in the case of a lump sum contract, the Activity Schedule,” in line 1 of clause 38.1
<b>GCC 39.4</b>	Replace the words “...value of completed activities in the Activity Schedule.” in line 2 & 3 of clause 39.4(b) by “percentage value of activities in the Activity Schedule subject to clause 35.2”.
<b>GCC 39.7</b>	Interim Payment for Plant and Material on site <b>only is</b> applicable. The payment will be 80% of the Project Manager’s determination of the cost of plants and materials delivered on site.
<b>GCC 40.1</b>	Amend clause 40.1 by replacing 21 days by 7 and 42 days by 28 days.
<b>GCC 41.1 (l)</b>	The term “exceptionally adverse weather conditions” is hereby defined as any one of the following events: <ul style="list-style-type: none"> <li>(1) 100 mm rainfall or above recorded in one day at the nearest rain station;</li> <li>(2) An official declaration of “Torrential Rain” by the Meteorological Department of Mauritius; and</li> <li>(3) Cyclone warning Class III or IV.</li> </ul>
<b>GCC 43.1</b>	The currency of the Employer’s country is: <b>Mauritian Rupees.</b>
<b>GCC 44.1</b>	The Contract is not subject to price adjustment.
<b>GCC 45.1</b>	GCC Clause 45 is not applicable.



<b>GCC 46.1</b>	The liquidated damages for the whole of the Works are <b>Rs. 5,250</b> per day.  The maximum amount of liquidated damages for the whole of the Works is 3% of the Contract price.
<b>GCC 47.1</b>	The Bonus for the whole of the Works is <b>not applicable</b> .
<b>GCC 48.1</b>	The Advance Payments shall be: <b>10 % maximum of the contract price less contingency sum and shall be paid to the contractor no later than Seven (7) days from the date of issue of certificate. The Advance Payment shall be recovered through contractor's running account bills at the rate of 12.5 % of the gross value of works done including materials on site.</b>
<b>GCC 49.1</b>	The Performance Security amount is <b>10 %</b> of the contract price in the form of a Bank Guarantee as per the format in <b>Section VIII</b> . and shall be valid up to a date <b>twenty-one</b> after the end of the Defects Liability Period (DLP). Where the Performance Security expire before the date <b>twenty-one days</b> after the end of the DLP, the contractor shall extend the Performance Security to cover the period up to the latest date of the DLP plus <b>twenty-one days</b> . Failure to extend the validity of the Performance Security <b>twenty-one</b> days prior to its expiry may entail forfeiture of the full amount of the Performance Security.  <b>Note:</b> The Contractor shall execute all work required to remedy defects or damage, as may be notified to him by or on behalf of the employer, on or before the expiry date of the DLP or any extended date if a defect or damage cannot be remedied by the expiry date, all at the risk and cost of the contractor.

<b>GCC 57.2 (g)</b>	The maximum number of days is: 60 days
<b>GCC 59.1</b>	The percentage to apply to the value of the work not completed, representing the Employer's additional cost for completing the Works, is <b>20%</b>
