

THIS AGREEMENT made on the ^{15th} 15 day of September, 2023, between **Ministry of Education, Tertiary Education, Science and Technology** (hereinafter "the Employer"), of the one part, and **Sonalall & Sons Building Contractor Ltd, Lot No. 2, Avenue Sayed Hossen, Carreau Laliane, Branch Road, Vacoas** (hereinafter "the Contractor"), of the other part:

WHEREAS the Employer desires that the Works known as **Construction of Swimming Pool (Bassin D'Apprentissage) at Permal Soobrayen Government School- Souillac** for the total amount of **Rs 34,747,500.00 (Rupees Thirty-Four Million, Seven Hundred and Forty-Seven Thousand and Five Hundred only)**, inclusive of a contingency sum of **Rs 500,000.00 (Rupees Five Hundred Thousand only)** and excluding VAT, should be executed by the Contractor, and has accepted a Bid by the Contractor for the execution and completion of these Works and the remedying of any defects therein,

The Employer and the Contractor agree as follows:

1. In this Agreement words and expressions shall have the same meaning as are respectively assigned to them in the Contract documents referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement. This Agreement shall prevail over all other Contract documents.
 - (a) the Letter of Acceptance
 - (b) the Bid
 - (c) the Addenda No. 1,2,3,4
 - (d) the Appendix to the General Conditions of Contract

3. In consideration of the payments to be made by the Employer to the Contractor as indicated in this Agreement, the Contractor hereby covenants with the Employer to execute the Works within a period of 300 days as from the start date of works and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
