This CONTRACT (hereinafter called the "Contract") is made the day of the month of Lebouard... 2024, between, on one hand, the Ministry of Education, Tertiary Education, Science & Technology (hereinafter called the "Employer") and, on the other hand, RSL Security Services Ltd (hereinafter called the "Service Provider").


