It is hereby agreed that –

- (a) Mr/Mrs/Miss hereinafter referred to as the Trainee under the Youth Employment Programme, shall be attached to a Primary School and perform the duties as mentioned at annex.
 - Perform such other duties directly related to the main duties listed at annex or related to the delivery of the output and results expected from Trainees in the roles ascribed to them according to their postings.
- (b) the period of traineeship shall be for period
- (c) the Trainee will receive, during the period of traineeship, an all-inclusive allowance of Rs(Mauritian Rupees) per month, including transport allowance, meal allowance and other incidental expenses;
- (d) the allowance referred to in paragraph (c) shall not be construed as salary or wages;
- (e) the Trainee shall not be entitled to any other payment during or after his/her traineeship;
- (f) the traineeship shall not give the Trainee any claim for employment in the Public Service;
- (g) the Trainee shall
 - (i) abide by the internal regulations of the Ministry and with regulations in force in the Civil Service;
 - (ii) perform any assignment entrusted as part of the traineeship;
 - (iii) comply with instructions given as part of the traineeship;
 - (iv) not reveal, during or after the traineeship, any information of a confidential nature acquired during the traineeship;
 - (v) not reveal, during or after the traineeship, to any third party or otherwise publish any information acquired or obtained as a result of or during the traineeship, without the written approval of the Responsible Officer of the Ministry; and
 - (vi) not absent himself/herself during the working hours without any valid reason.

- 2. The Ministry reserves the right to terminate the traineeship without giving notice, in case of misconduct or unsatisfactory performance by the Trainee. Where the traineeship is terminated under this paragraph, the Trainee shall not be entitled to any damage or compensation.
- 3. The Ministry may, by giving one month prior written notice, terminate the traineeship for any other reasons. In case the Trainee decides to withdraw from the traineeship before its completion, the Trainee shall give one month prior written notice to the (*Head of Ministry*) of such withdrawal, its effective date and the reasons thereof.
- 4. This Agreement shall not be construed in any way as to entitle the Trainee to be considered as a public officer or as giving the Trainee a right to a post in the Public Service.
