Education (Amendment No. 2) Regulations, 1958

GN No. 90 of 1958 22nd November

Regulations made by the Governor, on the advice of the Minister under section 38 of the **Education** Ordinance, 1957

- These Regulations may be cited as the Education (Amendment No. 2)
 Regulations, 1958, and shall be read as one with the Education
 Regulations, 1957, as subsequently amended, hereinafter referred to as
 the principal regulations.
- 2. Regulation 19 of the principal regulations shall have effect as if in paragraph (1) between the words " every year " and the words " to pupils of primary schools " there were added the words and figures "as from the year 1961".
- 3. The following regulation shall be added immediately after regulation 19 of the principal regulations-
 - 19A. (1) There shall be awarded in each of the years 1958, 1959 and 1960 such a number of scholarships as the Director may approve, not exceeding one hundred and twenty in any one year.
 - (2) These scholarships shall be awarded on the results of a written examination which shall be held at or about the end of the school year, and which shall be open to pupils of Government and aided primary schools and to other pupils who-
 - (a) shall not have completed their twelfth year on 1st July in the year in which the examination is held;
 - (b) shall have obtained in the primary school certificate examination a pass in English, French and Arithmetic, with not less than 66 per cent of the maximum marks in one of these subjects, 50 per cent in another and 33 per cent in the third or not less than 50 per cent in each subject; and
 - (c) in the case of pupils of Government and aided primary schools, shall have attended one or more of the abovementioned schools in the Colony of the year in which the examination is held and the two preceding years: provided that those three years shall include any leave approved by the director which the pupil may have spent away from the Colony.
 - (3) The scholarships under this regulation shall be awarded in the following manner, that is to say-
 - (a) seventy scholarships shall be awarded to boys; of which-

- (i) forty shall be awarded to boys from Government and aided primary schools who shall have obtained the highest number of marks from among the candidates from such schools;
- (ii) twelve shall be awarded to boys, not being boys from Government or aided primary schools, who shall have obtained the highest number of marks;
- (iii) eighteen shall be awarded to boys, other than those to whom a scholarship may have been awarded under the two preceding paragraphs, who shall have obtained the highest number of marks.
- (b) fifty scholarships shall be so awarded to girls; of which-
 - (i) thirty shall be awarded to girls from Government and aided primary schools who shall have obtained the highest number of marks from among the candidates from such schools;
 - (ii) eight shall be awarded to girls, not being boys from Government or aided primary schools, who shall have obtained the highest number of marks;
 - (iii) twelve shall be awarded to boys, other than those to whom a scholarship may have been awarded under the two preceding paragraphs, who shall have obtained the highest number of marks.
- 4. Regulation 22 of the principal regulations shall have effect as if in each of paragraphs (2) and (3) between the word and figures " regulations 19 and the word and figures " and 20 " there were inserted the punctuation, figures and letter ", 19A ".
- 5. Regulation 27 of the principal regulations shall have effect as if in paragraph (1) between the word and figures " regulations 19 " and the word and figures " and 20 " there were inserted the punctuation, figures and letter 19A ".
- 6. These regulations shall be deemed to have had effect as from the twenty-eighth day of December, one thousand nine hundred and fifty seven.

Approved by the Governor on the fifteenth day of November, one thousand nine hundred and fifty-eight and ordered to come into force at once.
