## Private Secondary School Authority (Amendment) Regulations 1981

## Regulations made by the Minister under section 22 of the Private Secondary Schools Authority Act 1976

- 1. These regulations may be cited as the **Private Secondary** School **Authority** (Amendment) Regulations 1981.
- 2. In these regulations-

"principal regulations" means the **Private Secondary Schools** Regulations 1977.

- 3. Regulation 3 of the principal regulations is amended by deleting item (a), (b) and (c) and replacing them by the following items-
  - (a) an admission register for students;
  - (b) an attendance register for students;
  - (c) a register of teachers and an attendance register for the teaching staff,
- 4. Regulation 3A of the principal regulations is amended by deleting the figures "15" and replacing them by the figures "21".
- 5. Regulation 6 of the principal regulations is amended in paragraph (a) by inserting after the word "Principal" the following words "or any other person designated by the Manager".
- 6. Regulation 7 of the principal regulations is amended by inserting after the word "Inspector" the following words "or an authorised officer".
- 7. Regulation 7B of the principal regulations is amended-
  - (a) in paragraph (1) by deleting the words "Primary School Leaving Certificate" and replacing them by the words "Certificate of Primary Education or any alternative certificate approved by the Minister"
  - (b) in paragraph (2)-
    - (i) by deleting the full stop at the end of sub-paragraph (b) and replacing it by a semi-colon;
    - (ii) by adding after sub-paragraph (b) the following subparagraph-
      - (c) where he has, without reasonable cause to the satisfaction of the **Authority**, been absent from the **secondary** school for more than four consecutive school weeks.
- (c) by deleting paragraph (3) and replacing it by the following paragraph-
  - (3) No student shall-
  - (a) be authorised to repeat any of the Forms 1, 11, 111, IV or V more than once;

- (b) be admitted to the Lower VI Form unless-
  - (i) he has not attained the age of 19 on the 1st January of the year of his proposed admission; and
  - (ii) he has passed-
    - (a) the Cambridge School Certificate with at least four credits at one and the same sitting in subjects approved by the **Authority**, or
    - (b) the Cambridge General Certificate of Education (Ordinary level) in five subjects (including English Language) at one and the same sitting with at least Grade C in four subjects approved by the Authority.
- 8. Regulation 8A of the principal regulations is amended by deleting the words "a student" and replacing them by the words "a student or the responsible party of a student".
- 9. Regulation 8B of the principal regulations is amended in paragraph (4) by deleting the full stop at the end thereof and adding the following words-
  - ", unless the **Authority** has, on application on that behalf made at least 15 days in advance, approved in writing of the change in the school calendar."
- 10. Regulation 9 of the principal regulations is amended in paragraph (c)by inserting after the word "day" the following words ", or part thereof,".
- 11. Regulation 9A of the principal regulations is amended by deleting paragraph (1) and replacing it by the following paragraph-
  - (1) The Authority may, on prepayment of a fee of-
    - (a) thirty rupees by any member of the teaching or non-teaching staff of a **secondary** school;
    - (b) fifteen rupees by a student;

issue to such member of the teaching or non-teaching staff or student as the case may be, an identity card in such form and subject to such conditions as the **Authority** may determine.

- 12. Regulation 11 of the principal regulations is amended-
  - (a) by lettering the provision contained in paragraph (1) as (a);
  - (b) by adding after the new sub-paragraph (a) the following sub-paragraph-
    - (b) An application for the issue of a transfer certificate shall be

made in such form and manner and within such time as the
Authority may approve

(c) in paragraph 2(a) by adding after the word "certificate" the following

words "or with the express approval of the Authority".

13. These regulations shall be deemed to have come into operation on  $27\ \mathrm{March}$  1981.
